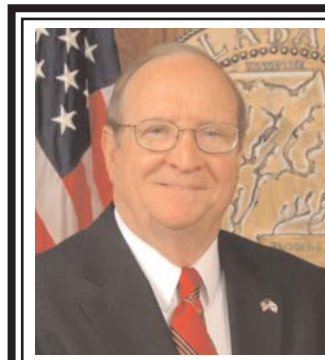
The Alabama Farmers and Consumers Bulletin staff is sincerely grateful to those who have been faithful advertisers and help make this publication so useful to all of the sub-

McMILLAN'S MESSAGE

Commissioner John McMillan

Just a few years ago, when government revenues were growing at a record pace, you did not hear people talking about state employee layoffs. How things have changed.

We're now in the midst of the third of three years of declining state revenues and double-digit proration is coming to the Alabama Department of Agriculture & Industries. What a difference a few years can make.

Looking forward, we must adjust to a new reality of a much smaller Department of Agriculture & Industries. Just over two months ago, when I was sworn in as Commissioner, there was some discussion of as much as a 10% cut in our General Fund revenue. Today, we face a 45% cut.

What this means is learning to do our job with less, \$7 million less. Our department has never been large. We are bound by state law to protect the food supply and regulate the \$5 billion agriculture and agribusiness industries with about a staff of 390 people. After the current round of budget cuts, we will be left with some 60 fewer employees to do the same number of inspections and certifications.

We have trimmed back and trimmed some more from our operation. People who perform the tasks required by law have been top priority. We take very seriously the critical work done by our inspectors, lab techni-

cians, veterinarians, and agronomists. Their work is the backbone of our department.

Unfortunately, I don't think the general public or a lot of other branches of government realize the responsibilities we have out there in the areas of food safety and consumer protection. That is unfortunate, because we are going to have to give up some territories in those areas.

If we should have an outbreak of avian influenza, exotic new castle disease or any other avian disease, it could potentially shut down the state's poultry industry. It is critical we keep the department functioning at a level to protect the state's top farm commodity.

It has been my responsibility to personally inform many of the employees who have been laid off in our department. Throughout this process, we have tried to remain as transparent as possible to inform employees of our fiscal situation and how it would affect us.

As we move forward, it is my goal to rebuild this department so that we serve agriculture, agribusiness and all Alabamians more proactively with a constructive relationship. Our intent is to see that we can help to make agriculture and agribusiness more prosperous. This will mean more jobs and opportunity for Alabama.

Sign Up for Precision Farming Ends April 29th

State Conservationist Dr. William Puckett with the USDA-Natural Resources Conservation Service (NRCS) announced April 29, 2011, as the cutoff date for sign-up for the Precision Farming Incentive under the Environmental Quality Incentives Program (EQIP). Applying for EQIP is continuous; however, selecting applications for funding is completed periodically through batching periods with specific cutoff dates.

The Precision Farming Incentive is designed to encourage the adoption of variable-rate application of nutrients and pesticides and promote the use of GPS-enabled precision agricultural technology and equipment. The goals of the

Precision Farming Incentive include improving water quality by targeting areas for reduced nutrient and pesticide application, reducing runoff and leaching of pesticides, enhancing soil quality through reduced erosion and soil compaction and energy conservation through accurate and efficient application of crop inputs. The Alabama Cooperative Extension System (ACES) is partnering on this initiative.

Under the Precision Farming Incentive, annually planted cropland in the following counties is eligible for 2011: Autauga, Baldwin, Barbour, Blount, Cherokee, Clay, Coffee, Colbert, Covington, Dale, Dallas, DeKalb, Elmore, Escambia,

Etowah, Fayette, Franklin, Geneva, Henry, Houston, Jackson, Lamar, Lauderdale, Lawrence, Limestone, Madison, Marengo, Marion, Marshall, Mobile, Monroe, Montgomery, Morgan, Pickens, Randolph, Russell, and Winston.

Interested producers should visit their nearest USDA Service Center to determine eligibility. Individuals are not eligible for EQIP until they have completed the Farm Bill eligibility requirements. Contact your local NRCS or Farm Service Agency Office to begin this process. NRCS field offices are listed in the telephone directory under U.S. Department of Agriculture or on-line <http://offices.sc.egov.usda.gov>.

Also during the event, the late Buck Appleton of Collinsville and the late John "Doc" Cottier of Auburn were honored posthumously as 2011 Agricultural Pioneer Award winners in recognition of the roles they played in shaping Alabama's agriculture industry. The ag alumni organization established the Hall of Honor in 1984 and since 1985 has annually increased its ranks by three. Biographical plaques of the new inductees and the 78 previous Hall of Honor awardees are located on the first floor of Comer Hall.

Agricultural Water Enhancement Program



The USDA Natural Resources Conservation Service (NRCS) recently announced April 29, 2011, as the cutoff date for signup for the Agricultural Water Enhancement Program (AWEP). Applying for AWEP is continuous; however, selecting applications for funding is completed periodically through batching periods with specific cutoff dates.

The Agricultural Water Enhancement Program promotes ground and surface water conservation and improves water quality by helping farmers and ranchers implement agricultural water enhancement activities. Alabama AWEP will focus on the installation of upland storage ponds. Stored water will be used during the summer for irrigation. Practices that will be available include:

- Constructing upland irrigation storage ponds.
- Installing pumps and pipelines to fill storage ponds.
- Irrigation system improvements or irrigation efficiency

enhancements to improve the efficiency of and reduce the energy needs of existing irrigation systems.

- Installation of soil moisture sensors and water meters to monitor and improve irrigation efficiencies.

AWEP was established by the 2008 Farm Bill and funding comes from the Environmental Quality Incentives Program (EQIP). NRCS administers AWEP by entering into EQIP contracts directly with agricultural producers. Funding for this project was a direct result of a grant proposal by the Alabama Farmers Federation, the Alabama Soil and Water Conservation Committee, and the Alabama Universities Irrigation Initiative.

All AWEP recipients must meet EQIP requirements. It is designed for bona fide agricultural producers that have been in crop production and have the need for water. The amount of storage will be determined by an irrigation budget based on the exact amount of water justified by the crops irrigated. Applicants must be in agricul-

tural production in order to apply. The statewide signup will be continuous with the first batching period ending on April 29, 2011. Successive batching periods may occur if additional funds become available.

Interested producers should visit their nearest USDA Service Center to determine eligibility. Individuals are not eligible for EQIP until they have completed the Farm Bill eligibility requirements. Contact your local NRCS or Farm Service Agency Office to begin this process. NRCS field offices are listed in the telephone directory under U.S. Department of Agriculture or <http://offices.sc.egov.usda.gov>. 2010 represented the 75th year of NRCS helping people help the land. Since its inception in 1935, the NRCS conservation delivery system has advanced a unique partnership with state and local governments and private landowners delivering conservation based on specific, local conservation needs, while accommodating state and national interests.

The Southeastern Equestrian Trails Conference (SETC) is a coming together of equine organizations and individuals (both private and public) that share knowledge, experiences and resources to enhance the equine world. Started in 1999, the National Symposium on Horse Trails in Forest Ecosystems - a conference for those interested in building, maintaining, and enjoying equestrian trails - was held at Clemson University. In the years that followed, annual conferences have been held throughout the southeast and became known as the Southeastern Equestrian Trail Conference. Today, SETC stands as the education forum for bringing equestrian interests together to share current information and build coalitions to support the equine trail industry.
