### NASDA MID-YEAR MEETING



NASDA members visited Capitol Hill during the Mid-Year Conference held in February.

Alabama Commissioner of Agriculture and Industries, John McMillan, recently attended the National Association of State Departments of Agriculture (NASDA) Mid-Year Meeting in Reston, VA. During this trip, Commissioner McMillan and Assistant Hassey Brooks attended meetings related to various areas within the agricultural sector, NASDA

task force meetings, panel discussions concerning the 2012 Farm Bill Implementation and a visit to Capitol Hill.

The Capitol Hill visit was very productive for the NASDA organization and Commissioner McMillan as several members of the United States House and Senate Committees of Agriculture presented updates concerning issues within the agricultural industry, budget constraints and factors that will play a key role for the preparation and implementation of the 2012 Farm Bill. The U.S. congressmen and senators who gave updates were: Senators Mike Johanns (ND) and Pat Roberts (KS) and Agriculture House Committee Chairman, Frank Lucas (OK), as well as other House Ag Committee members Glenn Thompson (PA), Jim McGovern (MA), Kurt Schrader (OR), Scott Tipton (CO), Tim Huelskamp (KS), Renee Ellmers (NC), Jim Costa (CA), Jack Kingston (GA), Randy Hultgren (IL).

"There will be 21 new members of Congress who will play key roles in the 2012 Farm Bill preparation," said McMillan. "Therefore, during the

2011 calendar year it is very important to understand the issues facing American agriculture and resolving potential concerns within each title of the Farm Bill."

Alabama will have two Congresswomen, Martha Roby and Terri Sewell, who will serve important roles within the House Committee of Agriculture.

"The staff at the Department of Agriculture & Industries and I are looking forward to working with all Alabama agricultural organizations," added McMillan. "We will be listening to Alabama farmers and producers on issues within current Farm Bill Titles and assisting as a line of communication with Alabama Congressional leaders."

To conclude the NASDA Mid Year Meeting, USDA Secretary Tom Vilsack addressed the membership during a reception held at USDA Headquarters. It was a great opportunity for new secretaries, directors and commissioners to have an opportunity to meet one another and discuss agricultural issues, which are impacting the United States.



### McMILLAN'S MESSAGE

Agriculture continues to be the number one industry in Alabama and the Ag Department has long had a good reputation for serving the farmers and consumers of the state. Since taking office as your commissioner in January, I have discovered that the employees of the department provide a variety of regulatory and protective services that are essential to our state having a vibrant and successful economy.

We all know that the Department of Agriculture & Industries supports farmers and producers by promoting Alabama products, encouraging people to buy local produce, and we introduce legislation that helps those in the industry do business. That is just a small percentage of what our employees do to serve the public. There is so much more going on in Alabama agriculture beyond our personal perceptions.

The Department of Agriculture & Industries has a constitutional obligation to regulate industry in Alabama. Our enduring mission is to protect our food supply from contamination or ruin, to increase and improve agriculture and industry growth, and provide accurate and meaningful regulation of the businesses and products that touch the lives of all the people of Alabama and the nation.

For example, you may already know that department employees in the Food Safety

section assure the quality and safety of food through wholesale and retail inspections of establishments, sampling, and enforcement activities relative to our Alabama food supply.

Our employees also regulate and educate individuals or companies that sell, use, or supervise the use of pesticides, engage in the commercial application of pesticides, and structural pest control and horticultural activities. Other employees issue permits for various licenses, conduct audits, and collect fees. Inspectors ensure that laws pertaining to feed, seed, fertilizer and other agricultural products are followed.

The State Veterinarian administers extensive programs of prevention, control and eradication of livestock and poultry diseases through Animal Industries, Vet Diagnostic Labs, and Meat Inspection. Stockyards and Brands issues permits, licenses, and certificates for livestock markets, livestock dealers, livestock weighers, and livestock brands. The Veterinary Diagnostic Labs provide diagnosis and surveillance of diseases of livestock, poultry, wildlife, and companion animals.

These are just a few examples of how important the ag department is to the people of this state. Without the services of these employees, our state's market would come to a halt affecting thousands of farms and small businesses, and

## GENERAL SIGN-UP PERIOD FOR CRP BEGINS MARCH 14

The sign-up period for farmers and ranchers to enroll eligible land in the Conservation Reserve Program (CRP) is set for March 14 through April 15, according to Daniel Robinson, executive director of USDA's Farm Service Agency in Alabama.

"Over the past 25 years, CRP's benefits have grown, thanks to many unexpected, but welcome improvements to our natural resources - cleaner water, improved air quality, better habitat for wildlife, viewing opportunities of that wildlife, and of course, a huge reduction in soil erosion," said Robinson.

The Conservation Reserve Program (CRP) is a voluntary program for agricultural land-owners. Through CRP, farmers and ranchers can receive annual rental payments (based on the agriculture rental value of the land) and up to 50 percent of the participant's costs in establishing approved conservation practices. Participants enroll in CRP contracts for 10 to 15 years.

Land currently not enrolled in CRP may be offered in this sign-up provided all eligibility requirements are met. Additionally, current CRP participants with contracts expiring this fall may make new contract

offers. Contracts awarded under this sign-up are scheduled to become effective Oct. 1.

To help ensure that interested farmers and ranchers are aware of the sign-up period, USDA has signed partnership agreements with several conservation and wildlife organizations, which will all play an active role in USDA's 2011 CRP outreach efforts.

FSA, which administers the CRP, will evaluate and rank eligible CRP offers using an Environmental Benefits Index (EBI), which shows the environmental benefits to be gained from enrolling the land in CRP. The EBI consists of five environmental factors (wildlife, water, soil, air and enduring benefits) and cost.

Decisions on the EBI cut-off will be made after the sign-up ends and after analyzing the EBI data of all the offers. In addition to the general sign-up, CRP's continuous sign-up program will be ongoing. Continuous acres represent the most environmentally desirable and sensitive land.

## LOW INTEREST LOANS AVAILABLE TO CATTLE PRODUCERS

The Alabama Agricultural Development Authority (AADA) continues to have monies available for three separate programs for creditworthy Alabama cattlemen. The low-interest loan programs require credit checks, repayment within 3-4 years, and must be fully collateralized. If one of the following programs meets your need, inquire at AADA, P. O. Box 3336, Montgomery, AL 36109; telephone 334/240-7245; or [aada@agi.alabama.gov](mailto:aada@agi.alabama.gov).

**Commodity Barn Loan Program:** Enable Alabama farmers to buy bulk commodities and subsequently realize likely feed cost savings. Three program amounts from \$7,500 to \$22,500 with 3 percent inter-

est and 3-year payback. Application required along with field inspection prior to loan being made.

**Hay Barn Loan Program:** Provide construction of approved new hay barns for Alabama cattlemen.

Access to a hay barn like-ly enables farmers to store hay under cover and subsequently receives significant economic benefits and improved hay quality. Hay barn plans must meet standard criteria with required field inspection prior to loan being funded. Either a \$12,500 (40' x 60' barn) or

\$25,000 (50' x 100' barn) loan is available based on need and herd size. Loans are funded at 4 percent for 4 years.

**Cattle Working Facilities Program:** Construction of improved working facilities for use on farms and ranches in Alabama. Enables increased efficiency in handling cattle along with better monitored herd health and improved production practices. Plans must receive approval prior to the start of construction. Loans are limited to a maximum of \$20,000 based on need and complexity of layout. Loans require a 3-year payback at 3 percent simple interest.

## Applications Sought for 2011 AITC Summer Institute

Applications are being accepted until April 15, for the annual Alabama Ag in the Classroom (AITC) Summer Institute, a grassroots program coordinated by the United States Department of Agriculture, that arms teachers with materials and strategies to increase student knowledge of agriculture.

Set for June 15-17, at the Marriott Shoals in Florence, the workshop will include activities for kindergarten through 6th-grade teachers and field trips to several area farms. The activities incorporate language arts, science, social studies and math skills.

"AITC is a program that educates teachers and students about agriculture in our state, and provides opportunities for children to learn about farming, and how important it is to our daily lives," said AITC Chairman Kim Earwood. "The Summer Institute provides books and hands-on activities that teachers can carry back to their classrooms. The activities teach children about agriculture, while at the same time reinforcing classroom curriculum of history, math, science, reading, and writing that complement the Alabama Department of Education's course of study."

The most popular part of the Summer Institute, however, is the farm tours, Earwood said.

"Our tours allow the teachers to actually meet a farmer and ask questions about what happens at their farm," Earwood said. "It helps make farming seem real, especially to those teachers who have never been on a farm. When you hear a teacher who has been teaching for 28 years tell you it is the best workshop she has ever attended, it shows that the program's efforts are all worthwhile and headed in the right direction."

Sponsors of the program, include the Alabama Farmers Federation, Alfa Insurance,

Alabama Cattlemen's Association, Alabama Poultry Contract Growers Association, Alabama Poultry and Egg Association, Alabama Farmers Federation State Soybean Committee and the Alabama Department of Agriculture and Industries. Proceeds from the sale of ag tags also benefit the program.
